





# CHAPTER 1: FAMILY AND MOVE TO TASMANIA

My grandfather, Oswald Ernest SINNOTT was born in Geelong, Victoria and died suddenly, at his business premises Sinnott's Service Station, Argyle Street, Hobart on 31<sup>st</sup> March 1941 at the age of 56 as noted on his Death Certificate. Also recorded in the Index of Deaths Volume 8 1941-1950 complied by The Launceston Branch of The Genealogical Society of Tasmania. There are varying records of his date of birth. For instance, a photo of his grave memorial citing Cornelian Bay Cemetery and Crematorium, Hobart



states, 'In memory of our dear Daddy and Pa OSWALD E. SINNOTT died 31<sup>st</sup> March, 1941 aged 58 years.' His date of birth cited between 1881 and 1885 in various articles.

His parents; William H Sinnott was born in Kildare, Ireland 1848 and Catherine Watkins, born Devon, England in

October 1848. They married on the 7<sup>th</sup> November 1874 in Geelong, Victoria and went on to have nine children. Oswald being the sixth. William Sinnott was employed by the Post and Telegraph Department in Geelong 1865 to 1874.

After attending Geelong Grammar School, Oswald was employed by the Department of Attorney General in 1900. (Indicating he may have been born early 1880's) He was employed by the Department of Lands and Survey. (No record of his school attendance has been located)

#### In 1904

Oswald married Isabella Mary Stewart, who was born 1876 in Prahran, Victoria and they had three daughters, Stella born 24<sup>th</sup> August, 1906 at Gertrude Street, Windsor, then twins Mary and Jessie born 1911 in Prahran.

In 1914 the family moved to Tasmania and bought a home in St John Street, Launceston. They kept their existing residence back in Melbourne and seemed to travel



between the two states regularly as the girls went to school at Windsor State School in Melbourne. Isabella and her daughters lived in Melbourne much of the time it appears.

While Oswald developed his career in Tasmania, firstly, as a Commercial Traveler with William Adams, then moved to the Texas Oil Company as their Tasmanian Manager. Here he developed links with Government agencies, many associations, similar businesses both in Tasmania and Victoria, regularly attending meetings. Oswald got to know Tasmania through his travels. He became highly regarded within the industry and also supported by the workers. They also celebrated winning the Texaco Cup by Tasmania.

Personally, their family life could have been quite challenging with the time spent in both Hobart and Melbourne. However, his three daughters once in their 20'seemed to spend much of their time in Tasmania, travelling around and making friends. Then at times back with their mother in Melbourne where Jessie and Mary studied at a Commercial College gaining high results. So, there was a lot of toing and froing by the looks of it.

In the early 1930's Oswald had met Emily Foley and they became close. In those days to divorce it appears you needed to go to the Supreme Court so many people did not change their legal status but got on with their lives however circumstances unfolded. In 1933 Oswald made a Will leaving his estate to Emily so they had become partners. His three daughters started to marry and have their own families. Stella married three times and had two boys, one born in Hobart 20th January 1927. Mary married and had three sons. Jessie lived with her mother in Melbourne from around 1935 till she married my father in 1939. They had a boy and a girl.

1933 16<sup>th</sup> May: OSWALD SINNOTT MADE A WILL which left everything to EMILY M FOLEY 68 VIEW ST HOBART TASMANIA.

1934 10<sup>th</sup> February: JESSIE SINNOTT became ENGAGED: Examiner, Launceston:

The engagement is announced of Jessie Catherine, twin daughter of Oswald Sinnott, Launceston to Geoffrey W. the eldest son of Mr and Mrs Wilfred C Swinson of Rotherwood, Mosman NSW.

(However the marriage did not proceed)



# CHAPTER 2: NEWSPAPER REPORTS

Oswald was in constant contact with newspapers to announce business updates, to promote his hobbies, express his opinions, encourage others to be proactive and to seek government change.

He became involved in Associations and attended many conferences which enable him to have a voice. The idea of a bitumen road between Hobart and Launceston seems to of developed from his firm and he lobbied council for the work. However, the articles show Texas Oil Co were not awarded the contract. Being outspoken Oswald voiced his disappointment.

Another major business event which he was passionate about was the introduction of Sunday Petrol Trading and he was President, Automotive Chamber of Commerce and a member of the Service Stations Association of Tasmania. Many articles are available where he expresses his extreme dislike of petrol stations staying open on Sunday. In fact, this probably had a huge impact on his health.

Oswald even appealed to the public not to support Sunday Trading on religious grounds.

To unwind and get back to nature Oswald had a pet Koala which he would put on display in the local City Park in Launceston seeking financial donations to the Launceston City Mission. He also supported the idea of Free Kindergartens suggesting godfathers and godmothers donate to the Free Kindergarten Association of Hobart. He was a patron of the Mowbray Pigeon Club and regularly displayed his talents around handling pigeons.

In 1935 Oswald left Texas Oil Company to concentrate on running his own service stations; Sinnott's Service Station, in Argyle Street, Hobart and New Town Service Station, in New Town. At the time of him leaving Texas Oil he was held in high esteem and well supported by management and workers.

Emily had been running the Sinnott's Service Station in Argyle Street up until when Oswald joined in the management and day to day running of the business. Previously Emily had been the Licensee of the Carlton Club Hotel which her husband, Alfred had been the proprietor until his death in 1922. Emily and Alfred married in 1913 in New Town, Tasmania where Alfred had grown up. They then lived in MacQuarie Street, Hobart South and the couple did not have children. Alfred had two children from his previous marriage.

The extensive articles that follow show the depth of Oswald's drive and determination to proactively encourage the many changes which he supported. The sale of petrol on Sundays seems to of been a passionate issue of his which may have affected him greatly. After several letters to many Newpapers seeking public and political support to stop Sunday Trading he seemed to fold, his Sinnott's Service Station went up for Sale and a week later he suffered a massive heart attack and sadly passed away at his business premises in March 1941.

Sinnott) wrote that the company had secured the lease of railway land adjoining that leased to the British Imperial Oil Co.and request the board to hasten the reclamation of Murdoch Street to the line of piles separating the railway and Marino Boards property, as such reclamation was necessary before they could level off the land leased and commence building operations.

1933 26<sup>th</sup> Dec. Examiner, Launceston: Article covering the Texas Company (A/asia) Ltd on behalf of the Tasmanian organization presented the Manager, Mr O. Sinnott with a handsome case containing a Waterman pen and pencil intended to convey the high esteem in which he is being held by the employees and to mark the occasion of winning the Texaco Cup by Tasmania.

1934 23<sup>rd</sup> May The Mercury, Hobart. PORT AFFAIRS article regarding INFLAMMABLE OILS on the discharge of oils at Hobart. A Conference attended by a number of managers from Oil companies including Mr. O. Sinnott, Texas Oil Company.



1935 7<sup>th</sup> March, The Examiner, Launceston. MOWBRAY PIGEON CLUB held its annual meeting at the Park Hotel. The patron (Mr O. Sinnott) was in the chair.

1935 17<sup>th</sup> May, The Mercury (Hobart) Mr Oswald Sinnott for many years manager for Tasmania of the Texas Oil Co (Aust) Ltd, is to retire this month.

### **EMILY MINTERN FOLEY**

1913 8<sup>TH</sup> April Emily Mintern BROWN married Alfred FOLEY, New Town, Tasmania, Australia Emily born 1885 in Fitzroy, Victoria to George Fyfe Brown and Mary Price. Alfred Foley born 1883 in New Town, Tasmania to Daniel Foley and Ann Rooney. Marital Status quoted as Widowed.

1916 residence : 171 MacQuarie Street, Hobart South, Tasmania.

1922 16<sup>th</sup> January death of Alfred FOLEY born 7<sup>th</sup> February 1882 proprietor of the CARLTON CLUB HOTEL.

He was on holiday for a few days on the mainland when his death occurred. Previously he worked with his brother Mr M.J. Foley having a leading tailoring business. Several horses have carried his colors on the turf. The deceased who was married a second time, leaves a widow and two daughters.

1920 12th October Hobart, Tasmania: INCOME TAX PROSECUTIONS. Several prosecutions on the part of the State Taxation Department resulted in convictions being recorded against defendants who had neglected to furnish returns for the year ending June 1919, after being requested in writing to do so. EMILY FOLEY of Hobart was among those ordered to pay a fine of 1pd and 6s 6d costs.

1929 1st March, Sinnott Argyle Street, Service Station petrol pump alight. The Advocate.

1929 28th November. Cyclist's Death collision intersection of Collins ad Argyle Streets with vehicle driven by Emily M Foley residing at 68 View Street, Sandy Bay.

# CHAPTER 3: TRAVEL

It is hard to present an overview of travel between Tasmania and Melbourne with just the following few travel records located from various sources. However, it appears Oswald may have visited Tasmania for the first time in 1909 before settling the family in Hobart in 1914.

The family seem to of travelled back to Melbourne at various times and the three daughters may have travelled back and forward together between school times and holidays. Isabella by herself for stays in both states probably coinciding with her daughters at most times.

Records show they resided at various times in property in both states.

Oswald travelled between the two states either by ship mainly the Loongana or flying for business on some occasions. In 1935 after leaving Texas Oil Co and having the two service stations which need to be managed, he travelled to Japan for a six-months holiday. There is an article dated 21st October 1935 in The Telegraph (Brisbane, Qld) (included below) which Oswald wrote.

His daughter, Mary with her husband and three children were living in Tasmania and working for him managing the service stations.

#### The following trips have been located, others may have occurred.

1909 13th January, aboard the LOONGANA is recorded the name SINNOTT. Melbourne to Launceston.

1924 1<sup>st</sup> May: arrival of the ship NEIRANA from Melbourne to Launceston passenger names include: E. FOLEY, O. SINNOTT.

1926 10TH Sept. Advocate Tas. Mr. O. Sinnott travelling through Railton by train.

1927 6th May Examiner, Launceston. Monthly Meeting of Evandale Water Trust attended by Mr. O Sinnott.

1929 11<sup>th</sup> August, The Mercury, Tas. the LOONGANA from Melbourne arrived Launceston with passenger SINNOTT. WAREATEA S.S. arrived over the weekend from Melbourne. She leaves tomorrow on return. DRYNJE M.B. left Beauty Point yesterday morning for Burnie after discharging a quantity of timber and oil for Hinman, Wright, and Manser, and Texas Oil respectively.

1934 1<sup>st</sup> Sept. The Mercury Tas. AIR SERVICES WESTERN JUNCTION AERODROME Departed August 31. MISS LAUNCESTON left for Melbourne at 9.30am and reached there at 1pm. Passengers included: O. SINNOTT.

1935 4<sup>th</sup> June The Mercury Tas. Mr O. Sinnott, formerly manager of the Texas Oil Co Launceston, left Launceston by the TAROONA yesterday for Melbourne, en route for the East. He will be absent about six months.

1935 21<sup>st</sup> Oct. The Telegraph (Brisbane, Qld). P13 – Cheap Taxi Fares in Japan. Article written by Mr. O. Sinnott now retired official of the Texas Oil Co. from Tasmania talks about the wonderful taxi drivers and cheap fares. A postcard of the Nippon Yusan Kalsha S S "NIKKO MARU" was amongst his daughter's photos.

During travelling to Japan his daughter Mary and her husband, Harry managed the two service stations. They lived in Tasmania for a few years and worked for him.

ARTICLE WRITTEN BY O.E. SINNOTT AND FEATURED IN THE TELEGRAPH (BRISBANE QLD) P 13 21ST OCTOBER 1935 CHEAP TAXI FARES IN JAPAN

According to Mr. O. Sinnott, a retired official of the

Texas Oil Co. from Tasmania, taxi fares are wonderfully cheap in Japan. A trip which would cost about four shillings in Melbourne may be done for 9td in Japan. The taxi drivers of Japan are in his opinion the best traffic 'dodgers' one could see anywhere. He marvels at their skill in winding their way in and out of the rapid and slowing moving vehicular traffic in the crowded thoroughfares. He was told that the beautiful harbours of Japan are in most instances the work of German civil engineers. From reliable sources this traveller learned that the Government must receive 51 percent of the holding before any foreign motor manufacturing concern could commence operations. He is a passenger in the Nankin.

1935 21<sup>st</sup> October WANTS TO TRADE WITH AUSTRALIA. JAPAN WILL SUPPLY OUR WANTS. HOBART MAN'S VIEWS. 'Japan is out to do a lot more trade with Australia than in the past,' said Mr. O.E. Sinnott, of Hobart, who returned from the East by the Nankin today. Mr Sinnott said that Japan was bonding men down in Australia and would keep sending them just to find out what Australians wanted. They will the see that we get it. This was not unreasonable, on account of the amount of stuff she bought from Australia. However, that was mostly wool, and they had to get it from .... He also spoke highly of the quality of goods manufactured in Japan.

1935 22<sup>nd</sup> October PASSENGERS BY THE NANKIN – Following is a list of passengers on board the liner Nankin which is due to arrive at Sydney on Wednesday October 23 from Japan – (list includes Mr O Sinnott).





1937 3<sup>rd</sup> April arrived In Launceston from Melbourne by Air Services Mesdames Sinnott. LOONGANA departed from Melbourne, 2.45pm Mesdames Sinnott. LOONGANA for Hobart 3.50pm Mrs E. Sinnott.


1940 14th Nov., The Age Melbourne. Mr O. Sinnott, president of the Garage and Service Station Association of Tasmania who is on a visit to this State, was welcomed at a meeting of the Council of the Retail Motor Dealers Association of Victoria.

### CHAPTER 4: DEATH

1941 1<sup>st</sup> April Examiner (Launceston)

### Mr. Oswald Sinnott

One of the best-known commercial travellers in Tasmania for many years. Mr Oswald Ernest Sinnott, of View Street, Sandy Bay died suddenly at his business



premises, the Argyle Service Station, Hobart, yesterday. (31<sup>st</sup> March 1941)

Mr. Sinnott was well known in the North, where for many years he was Tamanian Manager of the Texas Oil Company. He took a great interest in the affairs of the Commercial Travellers' Association. At one time he was Vice-president of the committee for some years and was a member.

He was born at Geelong, Victoria, 56 years ago and received his education at the Church of England Grammar School in that city. He came to Tasmania 27 years ago as a traveller for the firm William Adam. Then he became associated with the Texas Oil Company. At the end of his term with that firm he took a trip to Japan and shortly after his return settled at Hobart, where he established the Argyle Service Station, and later the New Town Service Station, which he conducted till the time of his death.

A prime mover in the establishment of the Garage and Service Station Association of Tasmania, he was state president of the association until the time of his death.

Mr Sinnott was a keen bird fancier and won many prizes in the North with his poultry exhibits. He also raised pigeons as a hobby and was a member of the Hobart Homing Club. Interested in bowls, he played often with the City Club. He was a member of the St. Andrew's Lodge, No. 8 T.C. (Launceston) and Perseverance Lodge, I.O.R., Melbourne. There are a few snippets of how the family managed and Oswald was a Commercial Traveller when he first moved to Hobart he worked for William Adams prior to becoming the Tasmanian Manager of Texas Oil Company. Oswald and his wife Isabella moved between Melbourne and Tasmania for a number of years.

There are newspaper reports covering Oswald's work contribution, his hobbies, travels and the changes to his personal life. Family photos are included relating to Tasmania.

Oswald travelled to Japan in 1935 which was a few years prior to the war and he was apparently there for six months. Research continues to try and determine if he was involved in any oil negotiations while in Japan.

He owned two service stations which he managed after leaving the Texas Oil Company. Oswald suddenly died at the Sinnott's Service Station in Argyle Street, Hobart, 31st March 1941.

There are twists to the story in his work and private life which lead to a further story of intrigue.
